Everything You Need to Know About the Pfizer Vaccine Approval from FDA

There is a significant milestone in the fight against COVID-19.

The COVID vaccine developed by Pfizer Inc. and BioNTech SE received full approval by the U.S. Food and Drug Administration (FDA) on Aug. 23, 2021. This is great news as the Delta variant continues to spread across the country.

What does this new development mean for you? Here is everything you need to know about the Pfizer vaccine and its full approval.

Vaccine Development

Pfizer's COVID vaccine, also marketed with the brand name Comirnaty, is developed using messenger RNA (mRNA) methodology to protect against infectious diseases. While the use of mRNA for vaccines is new, the technology has existed for decades. The COVID-19 pandemic has provided the opportunity to take this well-researched technology and put it to good use.

The mRNA vaccines make a safe, nontoxic "spike protein" that triggers an immune response inside the human body. This immune response, which produces antibodies, helps people gain protection and prevent them from getting seriously ill or hospitalized with COVID-19.

Status of Approval

The Pfizer vaccine, which received full FDA approval in Aug. 2021, is considered highly effective, safe and reliable for the prevention of COVID in individuals 16 years of age and older. This vaccine has met the FDA's highest standard of safety, effectiveness and manufacturing quality required for an approved product. The vaccine, which has been available under the FDA's emergency use authorization since Dec. 2020, is the first COVID-19 vaccine to receive full FDA approval.



The Pfizer vaccine for individuals 12 to 15 years old continues to be available under FDA's emergency use authorization (EUA), including the administration of an additional dose in certain immunocompromised individuals. Although an EUA is granted during a public health emergency, the approved vaccines have still undergone rigorous and comprehensive safety testing to achieve this status.

Approval Process

In order to receive the full FDA approval, the Pfizer vaccine went through a rigorous review process. FDA reviewed comprehensive data including longer-term, follow-up data from the Phase 3 trial, where the vaccine's high efficacy and favorable safety profile were observed up to six months after the second dose. They also reviewed manufacturing and facilities data required for licensure.

Why it Matters

The Pfizer's full FDA approval is an important step in the fight against the pandemic. Scientists and health care experts hope this approval boosts confidence in the vaccine and encourages more people to get vaccinated. The vaccine has shown to be highly effective against COVID, including the Delta variant. The vaccines help prevent severe illness, hospitalization and death.

Get the Vaccine

Scientific data has shown that COVID-19 vaccines approved by the FDA (whether this approval is a full FDA approval or under EUA) are safe and effective.

The fully approved vaccine from Pfizer and other vaccines from Moderna and Johnson and Johnson, which currently are available under the FDA's emergency use authorization, have proven to work against COVID, including the highly contagious Delta variant.

That's why BayCare urges everyone who is eligible to get vaccinated. Vaccines, which now are widely available at many county-run sites and local retailers, are the best line of defense against serious complications from a COVID infection.

UNSIGHTLY VEINS CAN INDICATE DEEPER PROBLEMS

“YOU CAN’T TELL A BOOK BY LOOKING AT ITS COVER.”



Many women are concerned about the appearance of spider veins and varicose veins. These veins, which can cause a spider web appearance in the skin, or big, unsightly bulges underneath the skin, can also cause a person to have symptoms and are signs of vein disease.



Ignoring these problems and not treating them can lead to a progression and further damage to the tissue of the lower leg. Some of the symptoms and signs of vein disease occur **predominately in the lower leg.**

Some of the symptoms include:

- Subtle feeling of fullness
- Mild aching, heaviness or pressure
- Fatigue as the day progresses

Some of the signs include:

- Swelling, which can be minimal but significant
- Rough, dry skin sometimes accompanied with itching
- Big, unsightly bulging veins underneath the skin
- Spider veins, the unsightly 'webs' in the skin itself, while considered cosmetic, usually indicate deeper problems

Over time, if untreated, vein disease can lead to more significant issues and more damage to the lower leg including, thickening and drying of the skin and discoloration, prominently a brownish color or, if the patient has been up on their feet for long periods of time, these sometimes subtle signs can lead to the possibility of an ulceration or sore around the ankle area.

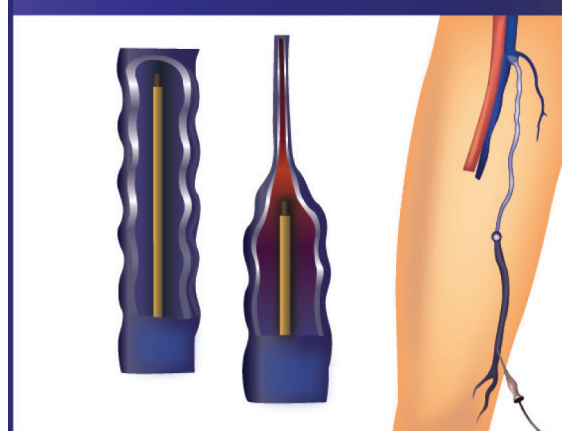
Fortunately, with today's technology, these issues can be dealt with in a very minimally invasive way with very little discomfort. Patients can return back to normal activities very quickly. At Vascular Vein Centers we use Endovenous Laser Treatment, which employs the thermal closing of diseased veins. We then use a foamed chemical to treat the actual varicose or bulging veins. These two measures are used to close the source veins. We then use a foamed chemical to treat of the actual varicose or bulging veins. This is done in an outpatient clinical setting avoiding surgery. These procedures are covered my most medical insurances, including MEDICARE.

Anyone concerned about the appearance of their veins should have a thorough physical and ultrasound evaluation to examine the underlying cause. This can be done quickly with very little disruption in one's normal schedule and activities. We strongly recommend wearing graduated compression stockings, hose or leggings while working or in situations where a person is on their feet or sitting for prolonged periods of time.

Vein health equates to leg health.

CHRONIC PAIN:

SPINAL CORD STIMULATION

Might Be the Answer You've Been Searching For

CHRONIC PAIN AFFECTS MORE THAN 1.5 BILLION PEOPLE WORLDWIDE, A NUMBER THAT OUTPACES HEART DISEASE, CANCER AND DIABETES COMBINED. THE CONDITION CAN NEGATIVELY IMPACT PERSONAL RELATIONSHIPS, PRODUCTIVITY AND A PATIENT'S DAILY ROUTINE. MANY PEOPLE TRY TO MASK THEIR SYMPTOMS WITH PAIN MEDICATIONS, BUT THESE CAN HAVE ADVERSE EFFECTS, AND SOME CAN BE HIGHLY ADDICTIVE.

That begs the question: are there meaningful alternatives for patients to find effective relief from chronic pain? The answer may lie with neurostimulation – a proven and established therapy that consists of small, implantable devices that use electricity to deliver pain relief to transform quality of life for many people who are otherwise unable to find relief from chronic pain.

SPINAL CORD STIMULATION

Spinal Cord Stimulation (SCS) is an implantable device that alters the pain signals as they travel to the brain, which reduces pain perception. It is a pain management therapy that delivers electrical stimulation to the spinal cord, dorsal root ganglion and brain.

Spinal cord stimulation or SCS is FDA approved and has been around for decades and has been used for over 40 years. Moreover, it has a highly proven success rate. Over the past few years, many overhauls have been made to the device, making it smaller, more precise and compatible with MRI imaging.

Spinal cord stimulation is classified as a neurostimulation device. It effectively redirects the pain messages, so that they do not reach the brain. This occurs through gentle yet effective electrical pulses. A unique feature to this type of neurostimulation treatment is that it's not something that a patient must commit to right away. In fact, there is a trial period for the SCS device. During this time, the physician and the patient can decide whether or not this is a successful therapy that should be implanted on a long-term basis. The trial period is normally one to two weeks and is usually ample time to make these decisions.

The implementation itself can be done under general anesthesia, or in some cases with twilight anesthesia, where the patient is minimally under sedation. Depending on the specifics of the patient's health and general wellbeing, it is usually performed in an outpatient facility.



WHAT HAPPENS DURING THE PROCEDURE?

- Sedation/Anesthesia is given
- The medical staff will prep your back for the procedure
- A tiny incision will be made on your back
- The surgeon will place the leads/wires into the epidural space
- These wires will conduct the stimulation of epidural space
- IF TRIAL BASIS: The tiny neurostimulator will be worn on a belt around waist
- IF LONG-TERM: An additional tiny incision will be made to house the small neurostimulator
- The leads are connected to the neurostimulator
- The incisions are closed with sutures (stiches)

The entire procedure takes approximately 1-3 hours to complete. The patient will receive a small handheld controller. This will enable the patient to control the amount of stimulation needed to redirect the pain signals, so that their pain is diverted, and they are essentially pain free.

This very common, yet highly effective treatment option is available for patients with chronic leg,

arm and back pain. Very often, it is used to treat patients that have undergone prior back surgery that was unsuccessful. It is also proven efficacious for other various forms of neuropathy and intolerable pain.

HALLOWEEN HORROR HAIR HELP

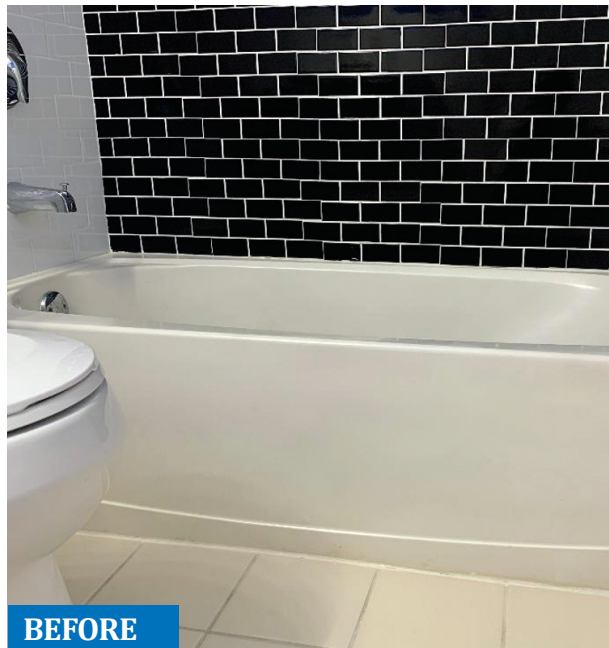
