

A BayCare Urologist Sheds Light on Overactive Bladder

What You Should Know About OAB Stimulants, Symptoms and Treatment

People with overactive bladder (OAB) often experience urgency at inconvenient and unpredictable times and may have trouble with leaking. Overactive bladder interferes with work, daily routines, intimacy and can reduce an individuals' self-esteem and quality of life.

n normal urination and a healthy bladder, the smooth muscles surrounding the bladder contract and relax in response to urine volume. With overactive bladder disorders, the muscle surrounding the bladder contracts frequently, resulting in high bladder pressure and the urgent need to urinate.

Overactive bladder is perhaps the most common thing I see in my urology practice. It can affect up to one in three women and one in four men throughout their lifetime, and the symptoms can range from a mild nuisance to a life-altering, debilitating disability.

When I see a patient with what's described as OAB symptoms, which is typically frequent trips to the bathroom to urinate day and night, my job is to make sure no other issues are causing the symptoms that are more dangerous, such as infection or malignancy, tumors, or neurological disorders. These types of symptoms often are coupled with blood in the urine. Men very often experience overactive bladder symptoms due to an enlarged prostate. Once I rule out these conditions, I start with very conservative approaches and then move to more involved treatment if necessary.

Most patients I see with OAB symptoms do not have dangerous disorders but rather an overactive bladder due to lifestyle habits.

I start by performing a diagnostic ultrasound to measure how the bladder processes urination. We ask the patient to urinate before the procedure. If they haven't fully emptied their bladder, we check for diabetes or neurological issues, and for men, we check the prostate.

If the patient can effectively empty their bladder but still feel the urgency to urinate frequently, I address their lifestyle habits. It's a common misconception that people have come to believe they need to drink excessive amounts of water. People who ascribe to a very liberal intake of fluids are having excessive urination. They believe they need to flush their kidneys, but the kidneys don't need extra fluids to work properly. This philosophy of more is better is like eating as much food as possible to flush the colon. It's not helpful.



Many patients are drinking 5 to 6 bottles of water per day, which is about 10 cups of water, plus other drinks. We get plenty of fluids from our food intake as well, so this thought process can lead to too many fluids. Unless someone is very active and sweating or parched with a dry mouth, etc., the fluid intake should not be more than a few cups of water per day. I ask patients to cut back on fluids and avoid overconsumption of caffeine and alcohol, which are dehydrating and stimulate urination. It's also critical not to drink anything 2 to 3 hours before bedtime.

Limiting fluids for approximately one month usually clears up the majority of my patient's issues with OAB. However, if this doesn't address the problem, there are other options to try.

For example, if a patient is on diuretics or certain medications that might contribute to OAB, we clear them for stopping those or perhaps reducing the dosage if it's not a life-threatening issue.

If these issues do not address the OAB, we can prescribe medications to control frequent urination.

These medications can help relax the bladder to help reduce urgency. If these medications work well for patients, we can usually wean them off those after a few months, and the patient's urination regulates on its own.

A minority of patients will need further treatment. For these individuals, we look inside the bladder and perform a urodynamic test to check the pressure.

Innovative interventions for severe case:

Newer interventions to treat complex OAB cases include Botox, which is injected into the bladder to relax the bladder. Within a few short weeks, most patients subside. Some people might need to have the procedure repeated if necessary.

Another procedure is sacral neuromodulation. A tiny wire (not much larger than human hair) is placed on the glut muscle with a quarter-size impulse device that sends messages to the brain to regulate urination. This procedure has approximately 80% effectivity. It only takes approximately 30 minutes, and if the procedure does not work, it can be easily removed.

Similar devices can be placed on the sacral nerve to induce sacral neuromodulation to send small impulses to the bladder. If a patient has OAB for any other reasons such as tumors, an enlarged prostate, we treat those depending on their disorder and condition.

Why? Because it's hot everywhere in July.



Ignoring these problems and not treating them can lead to a progression and further damage to the tissue of the lower leg. Some of the symptoms and signs of vein disease occur **predominately in the lower leg.**

Some of the symptoms include:

- Subtle feeling of fullness
- Mild aching, heaviness or pressure
- Fatigue as the day progresses

Some of the signs include:

- Swelling, which can be minimal but significant


Fortunately, with today's technology, these issues can be dealt with in a very minimally invasive way with very little discomfort. Patients can return back to normal activities very quickly. At Vascular Vein Centers we use Endovenous Laser Treatment, which employs the thermal closing of diseased veins. We then use a foamed chemical to treat the actual varicose or bulging veins. These two measures are used to close the source veins. We then use a foamed chemical to treat of the actual varicose or bulging veins. This is done in an outpatient clinical setting avoiding surgery.

These procedures are covered my most medical insurances, including MEDICARE.

Anyone concerned about the appearance of their veins should have a thorough physical and ultrasound evaluation to examine the underlying cause. This can be done quickly with very little disruption in one's normal schedule and activities. We strongly recommend wearing graduated compression stockings, hose or leggings while working or in situations where a person is on their feet or sitting for prolonged periods of time.

What is radiofrequency ablation?

Radiofrequency ablation is a treatment that uses electromagnetic waves to create heat. The heat destroys the nerve tissue that's causing your pain. With the nerve destroyed, the pain signal is no longer sent.

What conditions are treated by radiofrequency ablation?

Excel Pain and Spine uses radiofrequency ablation to help patients with chronic pain in the lower back, neck, and sacroiliac joints, which are located in the pelvis. Patients with joint pain related to arthritis may also benefit.

It's also possible to treat other pain conditions with radiofrequency ablation. The team at Spine & Pain Institute of Florida will give you a thorough evaluation to determine the best course of treatment for your symptoms.

How does radiofrequency ablation work?

Radiofrequency ablation is minimally invasive, and the procedure typically takes less than an hour. It's performed on an outpatient basis, and patients are usually allowed to go home after a short recovery period.

Typically, you are given a local anesthetic at the treatment site. Then, using a special X-ray, Dr. Jassal inserts a needle near the nerve that's causing your pain.


Once the needle is in place, a radiofrequency current is passed through the needle to create a precise burn on the nerve. This destroys the part of the nerve responsible for transmitting pain and disrupts the signal to the brain.

Excel Pain and Spine will provide you with specific postprocedure instructions, and these usually include avoiding driving for 24 hours as well as resting and avoiding strenuous activity for 24 hours.

Is radiofrequency ablation effective?

Yes. More than 70% of patients experience lasting relief with radiofrequency ablation. It usually takes 1-3 weeks for the treatment to take its full effect.

Pain relief typically lasts 6 months to 2 years, and for some patients, the pain never returns. It's possible, however, for the nerve to regrow. In these cases, radiofrequency ablation may be required again.





Are there any risks associated with radiofrequency ablation?

Radiofrequency ablation is a safe procedure with few risks of complications. Serious complications, such as infection and bleeding, are rare. Temporary side effects – which are also uncommon – usually only last 2-3 days.

They include:

- Localized numbness or weakness
- Mild discomfort or an increase in pain
- Swelling or bruising at the incision site

The treatment is not a good option for women who are or may become pregnant, people with an infection, or those who suffer from bleeding disorders.



New Drug Just Approved for HAIR GROWTH **SHOULD YOU TRY IT?**

drug the FDA approved last month can be helpful for regrowing hair in people with a particular type of hair loss called alopecia areata. However, it comes with some concerning side effects that every patient should consider carefully.

or years I've been perfecting hair restoration therapies that I know to be safe and effective, which I'll detail below, but let's start by taking a closer look at Oluminant (baricitinib).

Oluminant is now FDA approved to treat severe alopecia areata. Alopecia areata is an autoimmune disease that causes the body to attack hair follicles. This typically results in hair loss that ranges from small coin-sized bald patches on the scalp, or other areas like the beard or eyelashes and eyebrows, to total "whole body" hair loss. This condition can occur in both men and women and affects about 300,000 people in the U.S.

However, the hair loss condition more people are familiar with is androgenic alopecia. This is often referred to as "male pattern baldness," - although women have it, too - and manifests in the hairline, upper region of the temples, extending toward the back over time. Oluminant isn't intended for this condition.

Oluminant was approved after being shown to result in enough hair growth to be deemed "adequate scalp coverage" in between 17 percent and 32 percent of patients (depending on dosage) taking part in two double-blind, randomized, placebo-controlled clinical trials. Some of the regrowth seen in the clinical trials were downright dramatic.

Though that sounds positive, frankly I'm alarmed about its long list of potentially severe side effects (and so is the FDA). Oluminant is in a class of popular drugs called JAK-inhibitors which have been previously approved for arthritis and ulcerative colitis. They work by reducing the activity of overactive immune systems. FDA Boxed Warnings for the JAK-inhibitors Xeljanz (tofacitinib), Rinvoq (upadacitinib), and Oluminant (baricitinib) include "serious heart-related events, cancer, blood clots and death." I'm also concerned about as-yet unidentified unintended consequences and risks from this long-term, immune modulation therapy.

At Bauman Medical, we're known for applying effective advanced holistic and regenerative medicinebased hair growth treatments aimed at reducing the standard risks and side effects seen with more traditional therapies. Here are a few (but certainly not all) of my favorites for both alopecia areata and androgenetic alopecia.




